

Guidelines for the EtherCAT Product Guide @ www.ethercat.org

The following guidelines apply to entries in the EtherCAT Product Guide on the website of the EtherCAT Technology Group (ETG).

1. The EtherCAT Product Guide www.ethercat.org/products contains products that contain EtherCAT technology and products for use in EtherCAT networks. It also contains EtherCAT development environments, tools, and services. The ETG reserves the right to reject entries that do not correspond to the properties mentioned above.
2. ETG member companies are entitled to make several entries. If the number of entries per member exceeds an acceptable limit, several products can be combined in one entry. The ETG reserves the right to limit the number of entries depending on the content. ETG members who exhibit at ETG exhibition booths will be given preferential treatment.
3. Entries in the Product Guide are free of charge. A change can only be made through the ETG Membership Assembly.
4. Product entries can be revoked at any time.
5. TG will make entries and changes in a timely manner. Nevertheless, no fixed processing times can be guaranteed.
6. The ETG exclusively promotes EtherCAT. Mention of other fieldbus or Industrial Ethernet systems is limited to entries of gateways. If a device supports other systems, this can be mentioned in general terms (e.g.: "besides EtherCAT other fieldbus systems are supported").

8. The primary language for the Product Guide is English, entries in German, Chinese, or Japanese are also possible. Language-dependent forms can be used for this. The ETG recommends using the forms provided. However, if the use of a form is not possible, the following information can be submitted informally and without special formatting: Product type (main category, sub-category), product name, short product text (max. 200 characters including spaces), long product text (max. 2,000 characters incl. spaces), keywords (for Internet searches, max. 10).
9. Product photos are inserted in the size 200 px x 151 px (WxH). Photos with a resolution of at least 150 dpi in common graphic formats are accepted in all sizes and can be reformatted accordingly by the ETG.
10. Links can be added to a product entry, e.g. to a data sheet or a corresponding product area on the company website.
11. Texts, photos, and graphics of the ETG member companies must be approved, including copyright. Member companies guarantee the worldwide, non-exclusive, non-transferable, irrevocable right to free and unlimited use of the material made available. This right specifically includes the right to publish the material on www.ethercat.org as well as in newsletters, print media and other publications of the ETG.
12. The ETG and its representatives assume no responsibility for the content, correctness, completeness, or quality of the material made available. Liability claims for damage resulting from the use of the information made available by the ETG member companies do not apply. The liability lies exclusively with the member company.
